RESOLUTION OF THE GREENE COUNTY BOARD OF EDUCATION IN SUPPORT OF A BASIC EDUCATION PROGRAM HOLD HARMLESS LEGISLATION FOR THE 2021-2022 SCHOOL YEAR

WHEREAS, Coronavirus Disease 2019 (COVID-19) is a global pandemic that can lead to serious illness or death and spreads through close contact among individuals; and

WHEREAS, COVID-19 continues to spread at a rapid rate in Tennessee and has impacted school districts across the state; and

WHEREAS, Tennessee schools, in order to comply with Tennessee State Board of Education requirements, will likely have to engage in remote learning, in whole or in part, during the 2020-2021 academic school year due to the continued spread of COVID-19; and

WHEREAS, Tennessee school districts will be implementing different plans for learning from county to county across the state for the 2020-2021, based upon the needs of their students and COVID-19 outbreaks in each county; and

WHEREAS, the Basic Education Program (BEP) is the funding formula through which state education dollars are generated and distributed to Tennessee schools; and

WHEREAS, Student enrollment (average daily membership) is the primary driver of funds generated by the BEP; and there are 47 BEP components, most of which are based on student enrollment; and the funds generated by the BEP are divided into state and local shares for each of the three major categories: instructional, classroom and non-classroom; and

WHEREAS, because of COVID-19, it is likely that many families across the state may remove their students from public schools during the 2020-2021 school year and choose other learning options; and

WHEREAS, Tennessee schools may see a decrease in attendance in the 2020-2021 school year as families take precautions to combat the spread of COVID-19; and

WHEREAS, there is a one-year lag in how enrollment affects BEP funding amounts; and

NOW, THEREFORE, be it resolved unanimously by the Members of the Greene County, Tennessee Board of Education, That:

We, individually and collectively, support and respectfully request that the General Assembly and the State Board of education by legislation and/or by rule authorize BEP funding to not be decreased for the 2021-2022 school year and we request allocation amounts provided to local public school districts for the 2021-2022 school year be equal to or greater than the allocations for the 2020-2021 school year that local public school districts will not be negatively impacted based on student ADM of the 2020-2021 school year.

RESOLUTION OF GREENE COUNTY BOARD OF EDUCATION IN SUPPORT OF A MORATORIUM ON STATE STANDARDIZED TESTING FOR 2020-2021 SCHOOL YEAR

WHEREAS, His Excellency the Honorable Bill Lee, Governor of the State of Tennessee, has determined that outbreak of Novel Coronavirus Disease-19 (COVID19) has created a global pandemic in the United States and within the State of Tennessee that can and has led to serious illness or death through spread by close contact among individuals; and

WHEREAS, beginning on March 12, 2020, Governor Lee declared the State of Tennessee to be in a state of emergency until June 30, 2020, pursuant to his Executive Orders 14 and 36 due to COVID-19; and

WHEREAS, beginning on March 16, 2020, Tennessee schools were closed for the remainder of the 2019-2020 school year in response to requests made by Governor Lee that they be closed to combat the spread of COVID-19; and

WHEREAS, on March 18, 2020, the Tennessee General Assembly approved the cancellation of state standardized testing for the 2019-2020 school year, due to the statewide closure of schools and subsequent lack of standardized instruction being delivered to students; and

WHEREAS, on June 22, 2020, the Tennessee State Board of Education approved Emergency Rule 0520-01-17-.01, which requires Tennessee school districts to provide students in grades one (1) through twelve (12) access to six and one half (6 1/2) hours of instructional time each school day during the 2020-2021 school year even if there are school closures or disruptions related to outbreaks of COVID-19; and

WHEREAS, Executive Order 50 signed by Governor Lee on June 29, 2020 declared the state of emergency continuing until at least August 29, 2020 and as COVID-19 continued to spread at a rapid rate in the State; and

WHEREAS, in order to comply with State Board requirements, Tennessee schools will likely have to engage in remote learning, in whole or in part, during the 2020- 2021 academic school year due to the continued spread of COVID-19; and

WHEREAS, pursuant to State Board Emergency Rule 0520-01-17-.01, Tennessee school districts are required to create and implement their own plans to facilitate continuous learning considering the continued spread of COVID-19; and

WHEREAS, Tennessee school districts will be implementing different plans for student learning on various county by county plans across the State for the 2020- 2021 academic year, which will be based upon the needs of the students of each school district and taking into consideration COVID-19 outbreaks as they occur in each county; and

WHEREAS, Tennessee students will likely face significant academic and behavioral regression on returning to school after having lost approximately two (2) months of standard instruction and attendance due to the extended closures; and

WHEREAS, when schools resume in August 2020, students will have spent approximately five (5) consecutive months out of school; and

WHEREAS, Tennessee school districts will be focused not only on student growth and safety, but also on recoupment of academic, social and emotional skills lost during the extended closures.

NOW, THEREFORE, be it resolved unanimously by all the Board Members of the GREENE County Board of Education that we:

- 1. Support and respectfully request a moratorium on State standardized testing and accountability associated with such testing for the 2020-2021 school year, to include end-of-year examinations and formative assessments throughout theyear.
- 2. Request that if State standardized testing does continue in some format for the 2020-2021 school year, that the results of that testing be used as metrics of student progress rather than to determine district rankings and scorings statewide that will surely result from the inevitable disparity in learning methods that will be used across the State in light of COVID-19 and focus be made on recoupment of students' academic and social/emotional skills lost during the extended school closure.
